The App is an interactive and bilingual (Italian Sign Language (LIS) and Written Italian) Storybook App. It was created and illustrated by Silvia Palmieri. It was inspired by the children's books of Gianni Rodari and the publication of the App has been completed just as we celebrate a hundred years of this accomplished author. We presented the App to professionals, parents and the general public but also to deaf and hearing children at the Jumper Day event promoted by Save the Children.

Last July, the XVIII World Congress of the World Federation of the Deaf (WFD) was held in Paris with a focus on "Sign Language Rights for All". The WFD is an international non - governmental organization that promotes human and social rights of people who are Deaf. Many people gathered responded and to WFD's President Colin Allen's call to collaborate together in achieving tangible results for

individuals who are Deaf. Doctor Stefania Fadda, the Director of CABSS and President of the European Society for Mental Health and Deafness, was among the many participants at the Congress.

Last September I had the pleasure of being a guest along with former "Fulbright - Roberto Wirth" scholars at the first Fulbright Alumni meeting. It was an occasion to strengthen the connection members had with the Commission and create a community that can support its growth through mutual exchange.

In the area of fundraising, CABSS was the chosen charity of focus at the IV edition of the "Enrico Toti Award" and one of two charities at the Sistina Theatre. where the famous nanny Mary Poppins was the protagonist of one of the most acclaimed musicals of the year. SCIENTIFIC AREA

XVIII World Congress of the World Federation of the Deaf, The Right to Sign Language

"Sign Language Rights for All", was this year's theme at the XVIII World Federation of the Deaf (WFD) in Paris. The Congress was held on the $23^{rd} - 27^{th}$ of July with the patronage of the President of the French Republic.

In the country considered to be the "Homeland of Human Rights", the WFD strongly affirmed that Sign Language is a true cultural and linguistic resource, a fundamental human right that cannot be ignored from inclusive politics. Specifically, there is a need to go beyond the recognition of Sign Language in International Treaties by taking concrete action. This means: implementing the UN Convention on the Rights of Persons with Disabilities, ratified by over 170 countries including Italy and executing the 2030 Agenda for Sustainable Development, inspired by the principle of "leave no one behind", in order to create an inclusive, fair and sustainable world for all, where the rights of people with disabilities are fully respected.

The WFD is an International nongovernmental organization, established in Rome in 1951, that promotes the human rights of deaf individuals and their full participation in all areas of life. The WFD considers diversity within the Deaf Community on a global scale an added value, something that is seen at its World Congresses where all participants can meet and exchange experience and knowledge in an atmosphere full



of mutual respect.

The President of WFD, Colin Allen, believes it is important to work together to achieve tangible results and have full language rights to attain true inclusion of deaf individuals in society. For these reasons, the Ville Lumière saw the largest European gathering of all time dedicated to the rights of deaf people, welcoming 3,000 delegates and a large audience of deaf individuals, deaf individuals with other disabilities, CODA, hearing parents of deaf children, professionals and hearing people fully integrated into the Deaf Community.

Among the participants was Dr. Stefania Fadda who attended the Congress as the Director of CABSS and President of the European Society for Mental Health and Deafness.

The Congress' program included interventions by world experts on topics such as: Sign Language, Education for Deaf Children, Development and International Coopera-

tion, Technology and Accessibility, Health and Work.

First Fulbright Alumni Event

On the 30th of September, 2019, all former Fulbright Italian Scholars since the creation of the Fulbright Commission in 1948 all gathered to attend the very first Alumni meeting. It was created with the objective of reinforcing the affiliation scholars have with the Commission and creating a community of scholars that can connect with each other. The "Fulbrighter" new App was launched at the meeting and was developed to strengthen the knowledge and collaboration between ex-scholars around the world with the goal of favoring cultural exchange and mutual knowledge.

The event was held at the MAXXI Museum of Rome and enjoyed the participation of prestigious exscholars who, thanks to the Fulbright experience, have forged successful careers, such as: Professor Pasquale Tridico, President of INPS, Professor Maria Giovanna Dainotti, world renowned Astrophysicist e Knight of the Order of Merit of the Italian Republic and Doctor Massimo Ungaro, Financial Analyst and Deputy.

Coloboma of the eye and its impact on a child's education

What is Coloboma?

A coloboma of the eye is a defect in the structure of the eye that is present from birth. A coloboma is caused when issues occur during the development of the eyeball. Colobomas can occur on one or both eyes and can occur within different parts of the eye including the iris, lens, optic nerve, eyelid, or retina. According to the Osservatorio delle Malattie Rare in Italy it occurs in 1 out of 100,000 children.

Diagnosis

Due to the physical nature of the defect, a coloboma is typically identified by an ophthalmologist during an eye exam.

Implications

The primary impact of a coloboma on the iris is sensitivity to light. However, the impact of a coloboma on a child's vision is determined by how severe the coloboma is, whether or not it occurs in one or both eyes, and the location of the coloboma. Children with colobomas of the eye may have difficulty outdoors during daylight hours and/or inside under bright overhead lights. Children with more severe colobomas of the eye may also have difficulty recognizing facial expressions when communication partners are at a distance, identifying small images or letters on paper and may struggle with depth perception. Children may also experience blind spots or field restrictions.

Assessment

To determine the impact on education, a teacher of visual impairments (TVI) should conduct a Functional Vision Assessment. This will determine how a child is able to use his/ her remaining vision. In addition, a Learning Media Assessment should be conducted, as this will determine a child's primary modality to access the environment (vision, hearing, touch, etc.). Unfortunately in Italy there is not a visual specialist in the school system. CABSS however collaborates and offers consultation to families and school of how to best adapt and meet the needs of children with visual impairments such as Coloboma.

Curriculum Adaptations

When the effects of coloboma(s) are severe, additional supports may be required in the classroom. Due to the frequency of light sensitivity, children with coloboma(s) may require sunglasses, tinted lenses, visors, and/ or light covers in soft colors such as purple or blue to combat the harshness of overhead classroom lights. For classrooms with large windows and a high amount of natural light, black curtains can be used to cut back on glare. Children may also require adaptations such as enlarged text, a magnifying glass, assistive technology to access the curriculum in the classroom and use of contrast of print to be able to write, read, and use the computer more easily. It is very important that teachers are aware of the specialized needs of each child, how it can vary from child to child and take this into consideration when adapting the classroom.

ACTIVITIES AND PROJECTS

The First CABSS Storybook APP, "Il Mu What is it and where can I purchase it?

CABSS' First Storybook App, "II Museo degli Errori" is finally available on the AppStore. The app is interactive and bilingual (Italian Sign Language and Written Italian). It was created for preschool and elementary aged deaf children and has also been adapted for their hearing peers. The project was inspired by the books of Gianni Rodari, prized poet and author. We especially wanted to dedicate the publication of our app on the 16th of December,



2019 just in time as Italy and abroad celebrate 100 years of this gifted writer, a celebration that will continue well into 2020.

Developed and illustrated by Doctor Silvia Palmieri, 2014/2015 "Fulbright - Roberto Wirth" Scholar, the app was created and completed thanks to CABSS and the collaboration of the Motion Light Lab at the Science of Learning Center on Visual Language and Visual Learning at Gallaudet University, located in Washington D.C. (U.S.A.).

The "Il Museo degli Errori" app is a "Storybook app" that tells a story just like a book would, but in an interactive way utilizing an app allowing the child to choose whether to watch it in LIS or read it in Italian.

The project took into account recent studies on bilingualism and visual learning in deaf and hearing children and, through the integrated use of bilingualism and visual learning techniques, the Storybook app is an optimal learning tool that creates a unique reading experience. The colorful illustrations by Silvia Palmieri are designed to give readers a pleasurable and stimulating experience and younger readers are able to access the contents with ease.

Children can interact with the app in three ways:

- "Look": a video opens up with a story in LIS and young spectators find themselves as visitors in the colorful, unique and crazy world of "Stranalandia". A cool museum guide, played by a young deaf native LIS speaker, welcomes and accompanies viewers into the rooms of a Museum - "Il Museo degli Errori" and, on their adventure of discovering incredible people and stories where everything is "perfectly wrong", children are exposed to fun word games in Italian Sign Language (LIS), which stimulates their creativity and strengthens their language skills.

- "Read": children can access the story in sections. The story is divided in 22 short videos, each told in Italian Sign Language (LIS) and accompanied by Italian subtitles. In this area there is an opportunity to have an interactive reading experience. For example, when you click on a highlighted word in the story, a video pops up with the sign and the fingerspelling of the word. In this way children can learn the difference between LIS and Italian, learn new words and new signs. In addition, children can choose to read the whole story by "flipping" through videos or selecting a specific short video of the part of the story that they liked the most.

- "Learn": in this last section there is a glossary where you can click on a word and a video pops up with the sign and the fingerspelling of the word. The glossary contains a vocabulary more than 80 words carefully selected by the staff at CABSS and with the collaboration of Italian Sign Language (LIS) consultants.

The Storybook app is available on the AppStore for iPad. In the future it will be possible to find it also on the GooglePlay Store for Android.

Seminar: Launching of the "Il Museo degli Errori" App

The seminar dedicated to the presentation of the App was held on the 16th of December, 2019 in the Aula dei Seminari of the Istituto Statale per Sordi di Roma (ISSR). Organized by CABSS with the patronage of Gallaudet University, The Fulbright Commission for the Cultural Exchange between Italy and the United States and the ISSR. The Seminar was moderated by Doctor Stefania Fadda..

After the opening statements by Doctor Roberto Wirth and Doctor Paola Sartorio, the Executive Director of the Fulbright Commission, two excellent presentations were done by Professor Laura - Ann Petitto, from Gallaudet University, and Doctor Silvia Palmieri.

Doctor Petitto's presentation on "Language and reading advantages in the young bilingual child's brain: The role of bilingual reading apps", illustrated how early exposure to Sign Language positively impacts brain activity in deaf children. Thanks to this exposure, deaf children by the age of four, in respect to their hearing peers, showed increased visual attention, better sign phonological awareness and demonstrated visual sensitivity to letters on the page. Thanks to Storybook bilingual app's, like "Il Museo degli Errori", children have a learning tool that can support them in acquiring sign language and reading skills at a very early age, laying an optimal foundation for creating future motivated young readers.

Doctor Silvia Palmieri then presented on the "Il Museo degli Errori" App. She explained how it worked and emphasized how it empowers the element of choice making in children. Throughout the App children have the opportunity to decide what action they would like to take, such as looking at the story in LIS, reading, clicking on highlighted words or going directly to the glossary. Furthermore, the use of the Storybook app offers the opportunity to interact with parents, teachers or schoolmates by talking about the story and what is happening at the moment. Finally, Dr. Palmieri dedicated a space to "creative errors" something that Gianni Rodari created with the intention of utilizing it as a catalyst for fantasy and great discoveries. "In every error lies the possibility of a story," said Rodari, the phrase that inspired the creation of " Il Museo degli Erorri" App which teaches the child that errors are not always wrong but can create new opportunities to learn.

The seminar concluded with a video call from the United States with Melissa Melzkukn, the Creative Director of the Motion Light LAB, and Sofia Giansanti, the protagonist of the Storybook app who is currently studying in the United States. Sofia thanked CABSS for the experience in the creation of the App which allowed her to improve the use of LIS and facial expressions in order to express emotions in a more clear and accessible way for very young children.

<u>Public Testament</u>: it is written by a notary who states your requests in your last will and testament in the presence of two witnesses.

You can decide to give CABSS

- Money, shares and investments
- Real estate, such as an apartment
- Work of art, jewelery or furniture
- Your life insurance policy
- Your assets

In order for the document to be valid, it is necessary to clearly write "Centro Assistenza per Bambini Sordi e Sordociechi Onlus" in your last will and testament.

<u>Secret Testament</u>: is a confidential document that you must deliver in a sealed envelope to a notary, in the presence of two witnesses .

4. A testament solidifies your requests: with your testament you can be sure that your assets are destined, according to your wishes, to the people you care for and those you would like to help, such as the children at CABSS.

5. You can help CABSS without taking anything away from your loved ones: Italian law, in fact, protects close relatives by reserving the legitimate quota designated to them.
